I spoke with our lead tech about it, he thinks it just needs calibration which is part of the pm/cal for \$290 but it could need the co2 connector replaced which would be an additional \$120.

Very unlikely, but it could need a co2 board which is a couple thousand, but if that was the case you would be getting some sort of error message in most cases.

Hi Chief,

Sorry I missed your call.

The manufacturer service plans are nice for budget setting since they are flat rate, but as you know there are very expensive.

Our approach to service and repair is only pay for what you need.

I ran a report for the total repair costs of 104 Lifepak 15's we have recently serviced from customers across the US.

The units ranged in age from version 1 units to version 4's.

The average cost to service and repair a Lifepak 15 through us was \$575.80 which included the \$290 pm/cal cost.

There were only 10 units whose visit to us costed over \$1000 with the most expensive one being \$3999.80

Something to also note, though rare, if there is some sort of major failure we will offer a used replacement part if available or trade in the unit towards a replacement if that is more economical than purchasing a new replacement part.
